## RESOLUTION FOR SALE OF DISTRICT PERSONAL PROPERTY

1. Said personal property is deemed to be no longer necessary for school purposes for the Geneseo Community Unit School District No. 228, and that it is in the best interests of said school district that this property be sold.
2. Said personal property shall be sold at auction to the highest and best bidders at a public auction to take place on April 17, 2016 at 12:00 P.M. at 106 East Ogden Street, Geneseo, Illinois, and as further set forth herein.
3. Said personal property shall be sold "as is" and with no warranties or representations of any kind, for cash paid by the successful bidder to the Superintendent or his designee at the time of the public auction.
4. This Board approves and authorizes publication of materials to advertise the public auction for said property, if so desired by the Superintendent or his designee.

5. Said personal property not sold at public auction may be sold after said public auction to individuals at a price deemed reasonable by the Superintendent or his designee, and under the terms and conditions described herein.
