Review of October 7, 2010 Sub-Committee Meeting Minutes

The minutes from the Wellness Sub-Committee Meeting were reviewed. At this meeting, the new District Policy 7:285 was discussed and recommended for approval by the Geneseo Board of Education. Nutrition and Physical Activity were also discussed at this meeting.

Board Policy 6:50 – School Wellness

Policy 6:50 was approved by the Geneseo Board of Education on April 16, 2009. This policy was reviewed again by the members of this committee. The only recommended change would be in the first paragraph on the first page of the policy. The year of the Child Nutrition and WIC Reauthorization Act of 2004 should be changed to 2010.

Board Policy 7:285 – Food Allergy Management Program

Copies of Board Policy 7:285 and 7:285-AP were distributed and reviewed. This policy was just approved at the November 11, 2011 Geneseo School Board Meeting. As a result of this policy, two new members were added to this Committee. Both of these members have students in the District with food allergies. They shared their thoughts with the group. Currently, both of them are very pleased with the services and accommodations that the schools are making for their children.

Nutrition

The list of “Healthful Food and Beverage Options for School Functions” was briefly reviewed. Mr. Schlindwein informed the group that all of the schools were given copies of this in August of 2010. Most of the people thought the list was useful.

Ms. Hepner explained to the Committee the “Limited Fat” issue that may be coming from the Federal Register in the near future. The pros and cons of these “rules” were briefly discussed.

This Committee continues to recommend that teachers stress the importance of good eating habits in the classroom.

Physical Activity:

The District continues to align their physical education curriculum with those outlined in the Illinois Learning Standards. Physical education instruction takes place at the elementary level three (3) days per week and is taught by the P.E. teacher. Two (2) days a week the classroom instructor is responsible for the P.E. instruction. At the middle school and high school levels, P.E. is taught every day of the week.

Mr. Schlindwein will check with Dr. Swanson on how the topics of nutrition and fitness fit into the K-8 curriculum.

Even with a well-outlined physical fitness program being implemented in the District, we still have a large percentage of students in the District that are overweight and obese. Mrs. Rokis presented the Committee with a “Summary of Children’s BMI-for-Age” (see attached reports for elementary, middle school, and high school information). According to these reports, 35% of our elementary students are considered overweight or obese; 30% of our middle school students are considered overweight or obese; and 37% of our high school students are considered overweight or obese.

Other:

Mrs. DeSmith, M.S. nurse, asked that a time be set up at the beginning of each school year for the nurses to meet with the teachers of students that have special needs (i.e.: food allergies, diabetes, etc.). This meeting will be beneficial for the students, parents, and teachers. Mr. Schlindwein will share this request with the District’s Professional Improvement Committee.

Mr. Schlindwein told the Committee that this information would be shared with the Board of Education at their March 10, 2011 Meeting. The Committee adjourned at 4:05 P.M.

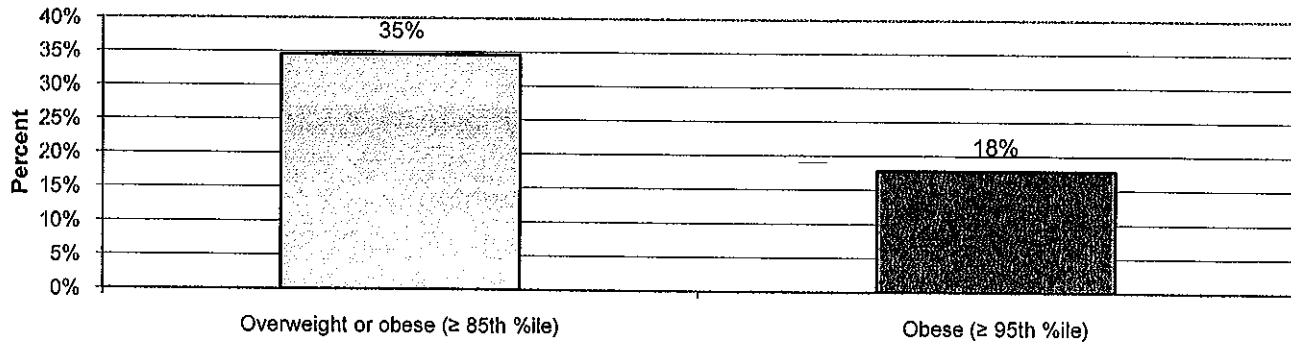

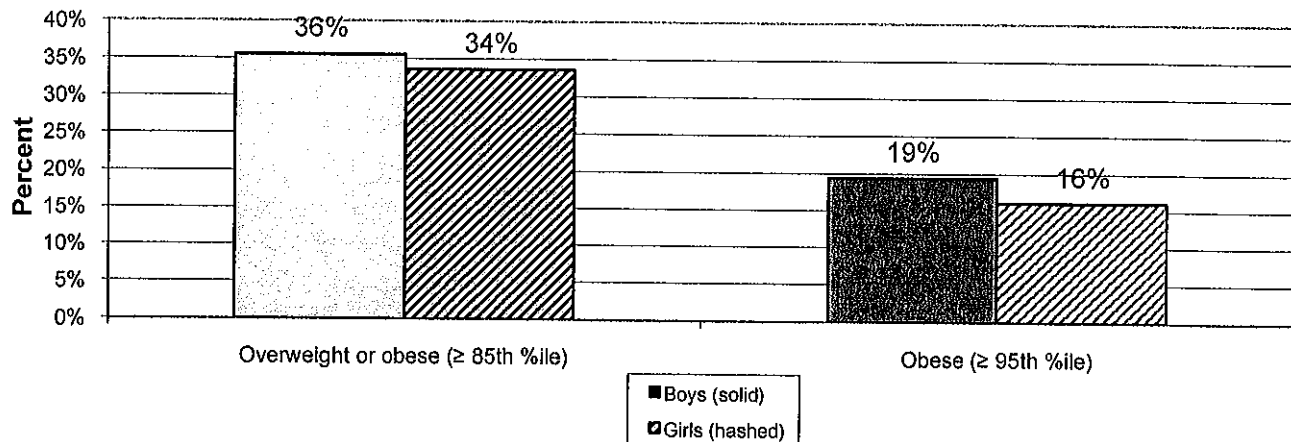

Prevalence of Overweight and Obesity, by Sex



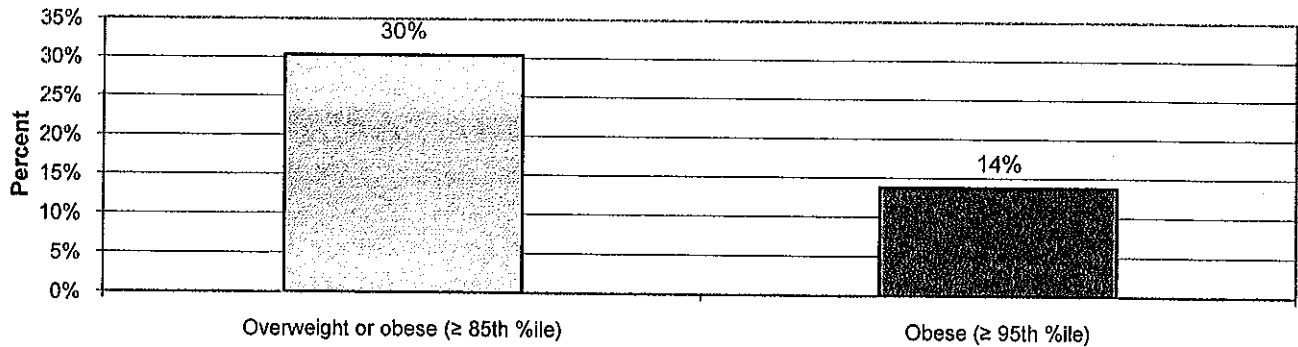

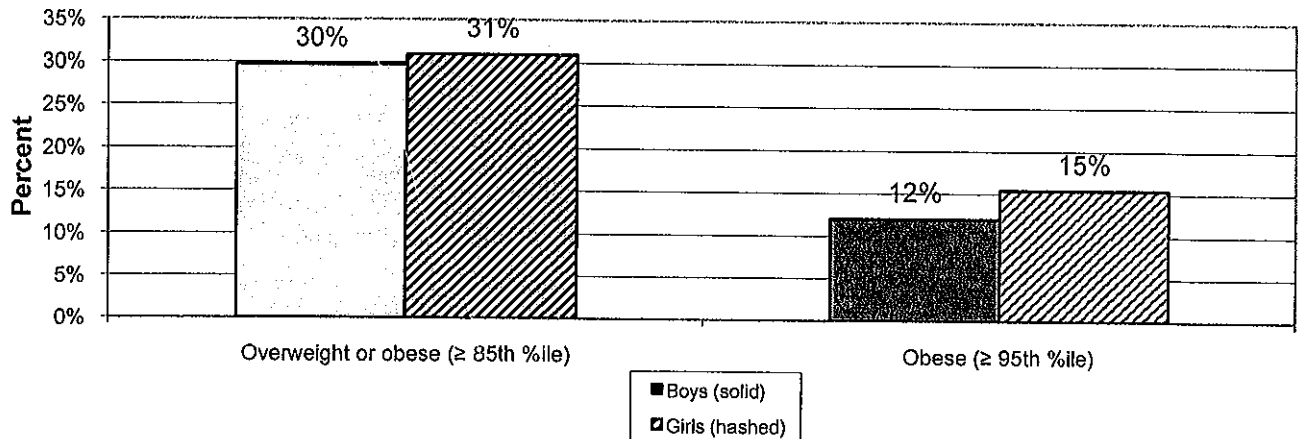

Prevalence of Overweight and Obesity, by Sex



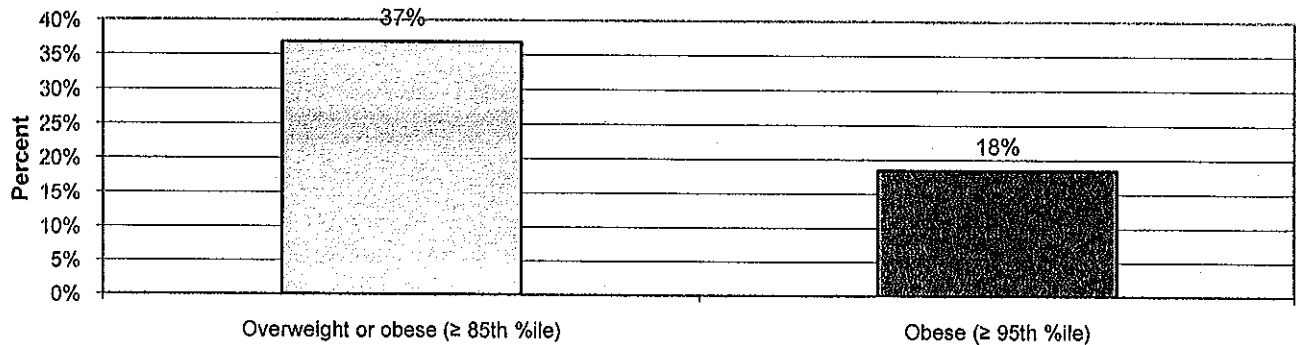

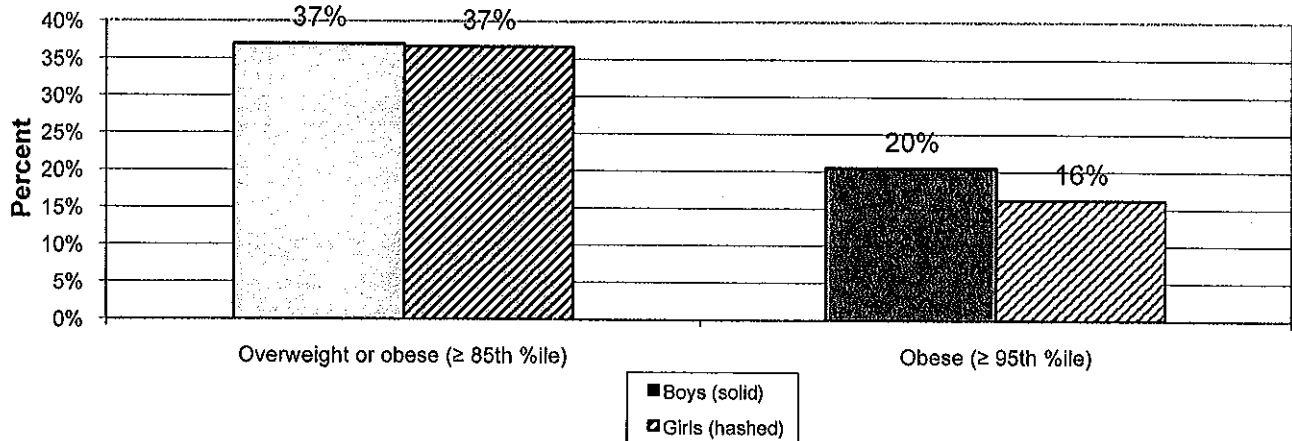
