### Keynote Speech:

#### Building Trust in an Era of Transparency presented by Jim Nowlan

Jim Nowlan brings a unique perspective to the topic of governmental transparency. During his keynote address, Nowlan will discuss the importance of transparency in local government and why it is more important today than ever before.

Nowlan considers himself a jack-of-all-trades in government and politics. He is a former Illinois state agency director (on three occasions), member of the Illinois House of Representatives, and counselor to Illinois Republican governors Richard Ogilvie, Jim Thompson and Jim Edgar.

Nowlan publishes *The Stark County News* and *The Chillicothe Independent* community newspapers in central Illinois, and operates a music venue and historic community center in his home village of Toulon. He is also the author of scholarly works and novels about American politics, public management and social change.



Active in public service, Nowlan chaired the Union League Club of Chicago's Constitutional Convention Committee. He is also a member of the boards of the Central Illinois Council of the American Red Cross and the Mikva Challenge Fund, which provides political training for inner-city high school students, primarily in Chicago.

Nowlan, 67, received his bachelor's, master's and Ph.D. degrees in political science, with minors in economics, from the University of Illinois at Urbana-Champaign.


