

AGREEMENT

The undersigned, Geneseo Community Unit School District No. 228 of Henry and Whiteside Counties, Illinois (“District”) and Pinks’ Bus Service, Inc. of Geneseo, Illinois, (“Contractor”) do hereby agree to extend the Transportation Contract extended by Agreement May 8, 2014, for a period commencing July 1, 2014 and continuing in full force and effect for the 2014-15 school year and terminating on June 30, 2015, provided, however, that said Agreement as so previously amended and extended shall be amended and extended as follows:

1. The provisions regarding COMPENSATION shall be modified by substituting Exhibit A attached hereto and incorporated herein by reference that shall constitute the description of transportation charges assigned by the Contractor to the District for the 2014-15 school year.
2. The total number of routes shall be determined in consultation between Pinks’ Bus Service, Inc. and the Geneseo Community Unit School District Administration. The District reserves the right to modify drop-off and pick-up times as long as it does not create any adverse logistics for Pinks’ Bus Service, Inc.
3. The District and the Contractor shall formalize any new procedures for scheduling/cancellation of trips for athletic events, field trips, extra busing, etc. and those procedures shall become memorialized as an addendum to this Agreement.
4. The District and Contractor shall agree that during 2014-15 compensation of \$1,000 shall be paid for the elimination of the one bus route reduced prior to the 2012-13 school year. The compensation shall be \$1,000 for said reduction of route payable in the 2014-15 school year.
5. The Contractor shall provide a recommendation to the Superintendent before 5:00 a.m. whether or not to cancel school due to inclement weather or other safety factors. If inclement weather occurs during the school day hours, the Contractor shall contact the Superintendent and make a recommendation for the early release of students at an agreed upon time.
