

## GENESEO CUSD –GYBS 2021 USE OF BOLLEN FIELD DIAMONDS AND J.F. EDWARDS FIELD DIAMONDS

The J.F. Edwards diamonds shall be available for use, in order of priority scheduling by:

- 1. Geneseo CUSD 228 Teams.
- 2. GYBS and affiliated teams.
- 3. Geneseo Youth Independent/travel teams.
- 4. Other

Scheduling shall be done by a Geneseo School District designated person. The "scheduler" will coordinate diamond use for practices/games/tournaments for the above organizations and will communicate monthly schedules to the Geneseo School District.

GYBS will provide the appointed scheduler with practice and game schedule for the J.F. Edwards Field Diamonds after registration in March. If needed earlier, GYBS will estimate schedules, so field usage times can be blocked and reserved. Tournament requests by any group shall be approved by the GYBS President and the scheduler prior to schedule entry.

CARE OF DIAMONDS:- All four J.F. Edwards Field diamonds/fields will be mowed year round by the Geneseo School District; The Geneseo School District will mow the Bollen Field Big Diamond until the H.S. Baseball season is over; The Geneseo School District will "drag" J.F. Edwards Diamonds 1, 2, 3, and 4 every day around 1:00 P.M.; ONLY the following people may use the "belly rake" to drag the diamonds: District employees, Jesse Dobbels, or the designated GYBS employee responsible for diamond care. On the weekends, GYBS must employ their designated person, Jesse Dobbels, or an approved District employee to drag the J.F. Edwards Diamonds. NO other equipment should be used to drag the diamonds. The District will supply MSA as needed.

GYBS will maintain trash on the J.F. Edwards Field Diamonds following GYBS events. GYBS requests the District maintain trash using District dumpsters for District events.

GYBS requests the use of the J.F. Edwards Field concession stand for GYBS events. GYBS will maintain the concession stand and bathrooms following GYBS events.

GYBS will supply chalk for GYBS programs, the District will supply chalk for District programs. Independent teams will supply chalk for independent games.

GYBS and the Independent groups below agree to this annual contract with the District for use of the J.F. Edwards Diamonds. There will be no charge for these diamonds. A Certificate of Insurance must be on file in the Geneseo CUSD Unit Office for GYBS and any Independent organization using the complex.

The Geneseo CUSD will **invoice** GYBS for electricity and sewer for the summer months where no Geneseo CUSD events are scheduled. The Geneseo CUSD will be responsible for water usage during the scheduled game and practice IHSA outlined dates. If the District uses any lights during this time period, they will reimburse GYBS. Any travel team or tournament team that uses the lights on the J.F. Edwards Diamonds during this time frame would also reimburse GYBS.

GYBS understands that this is a working agreement and is amendable by the District and GYBS. GYBS understands that there may be a need to share resources to control costs. GYBS wants to continue the environment of cooperation with the District. GYBS requests that the District Superintendent or his designee communicate directly with the GYBS President on any future concerns. The above defined protocols and agreement will remain in effect annually until a need arises to create an addendum to this agreement at which all parties will review proposed changes to protocols and re-sign the agreement for the Board of Education.
