
2013 Tax Levy Filed in December 2013

For Property Taxes Payable in 2014

Revenues for the 2014-15 School Year (June & September)



The following tentative levy data is based on the most recent EAV estimation provided by the Henry County Assessor Lindi Kernan. I recommend using this EAV estimation of \$325,005,731 for the 2013 Geneseo School District 2013 Tax Levy. This EAV represents a 1.73% increase from 2012. If more current information should become available from County Assessor Lindi Kernan we will update it for the December Tax Levy Hearing if necessary.

Goals/Options for the Board to Consider for the 2013 Tax Levy:

- A. Access the maximum levy (balloon levy) in funds which have legal rate limits due to projected budget deficit spending. This levy would require a Truth in Taxation Hearing.
- B. Request a levy that demonstrates sensitivity to local tax payers by levying a dollar amount that yields a tax rate equal to the 2012 levy tax rate of \$4.06.
- C. Request a levy that is a middle ground between a balloon levy and an unchanging tax rate scenario.
