The CASEL 5 framework was reviewed and discussed. The CASEL 5 addresses five broad, interrelated areas of competence and examples for each: self-awareness, self-management, social awareness, relationship skills, and responsible decision making. It can be taught and applied at various developmental stages from childhood to adulthood and across diverse cultural contexts to articulate what students should know and be able to do for academic success, school and civic engagement, health and wellness, and fulfilling careers.

Benefits of SEL were reviewed and discussed with an emphasis on what we want to share with our teams, how we can model/use the SEL Playbook in our delivery of the Framework to teams, and what information we want to collect from our teams.

Other resources to consider are RR- Kim Meyer (SEL Coach), East Moline- Alan Dassow (SEL Coordinator) and the Illinois Social Emotional Learning Conference on February 20, 2024.

Next steps include determining what feedback to collect, finishing the leadership team presentation and collecting feedback, Ashley/Sarah working on a skeleton presentation for the leadership team, and a target meeting date for the SEL team during the first week of October.

A roundtable format was used to discuss the Gum Drops (Grace Methodist) program and morning playtime for moms at home (50 children ages 1-5 signed up). The committee aims to serve our community without stepping on the toes of other existing centers by pulling students/staff away from their facilities. Staffing continues to be a struggle, and the committee explored whether students are on a waitlist because of staffing or because seats are not available.

A presentation on ISBE/DCFS Supported Early Childhood Programming Options was given by Dianna Saelens. Key considerations for funding/ISBE focused on where are the areas most at risk (80% below poverty line) and collaborations (how are districts working with centers and PreK centers in the areas and how are programs partnering with one another?). Three Innovative Service Models were reviewed, as well as facility requirements, staffing requirements, yearly costs of childcare services, and child care assistance programs.

The committee also reviewed and discussed survey results and logistics for upcoming visits—an lowa school tour is in the works for October 25.
