To whom it may concern:

I am writing to you on behalf of LocalLabs which is an online publication that reports on and informs the public about local government activities. If you are not the FOIA officer please forward it to the FOIA officer or reply to this email with the correct FOIA contact.

Pursuant to the Illinois Freedom of Information Act, I am requesting electronic records of any contracts and documents relating to business with Panorama education, specifically:

- (1) a copy of the signed contract with Panorama
- (2) a list of all payments made to Panorama
- (3) copies of all materials used by Panorama in training / curriculum per the contract
- (4) a list of all teachers and classes (students) who have been exposed or instructed to Panorama materials

The purpose of the request is to access and disseminate information as a matter of public interest and is not for the principal purpose of personal or commercial benefit. I qualify as media under the definition in Section 2 (c-10) ("Commercial purpose"), Section 2 (f) ("News media"), Section 2 (g) ("Recurrent requester"), and Section 2 (h) ("Voluminous request") of the Freedom of Information Act, for the purposes of being exempt to the provisions of Section 3.1 (Requests for commercial purposes), Section 3.2 (Recurrent requesters), Section 3.6 (Voluminous requests), and Section 6 (Authority to charge fees). Therefore, I request you furnish any responsive documents and items without charge.

Dear Dr. Brumbaugh,

I hope this email finds you well.

My name is Sheri Reid and I'm reaching out on behalf of SmartProcure to submit a commercial FOIA request to the Geneseo Community Unit School District No. 228 for any and all purchasing records from Dec 5, 2017 to current.

Considering the size of this request, we can reduce it for your agency, if need be, and request the remaining information later. If this would be helpful in getting our request addressed, please let me know.

The request is limited to readily available records without physically copying, scanning or printing paper documents. Any editable electronic document is acceptable.

The specific information requested from your record keeping system is:

1. Purchase order number. If purchase orders are not used a comparable substitute is acceptable, i.e., invoice, encumbrance, or check number
2. Purchase date
3. Line item details (Detailed description of the purchase)
4. Line item quantity
5. Line item price
6. Vendor ID number, name, address, contact person and their email address

If you would like examples of reports that would fulfill our request, please feel free to reach out via email with the name of the financial software your agency uses.
