First, I would like to thank the board members and administrators of District #228 for the support and guidance you provide for the nursing staff throughout the year. This annual report is designed to give you an insight into the daily activities and programs that the nurses have been involved in during the 19-20 school year. As you may have expected this year's report will be slightly different then in the past due to the Governor's executive order for school closure. The line items in red have been cancelled, changed or postponed due to the COVID19 Pandemic.

Each school year has its own challenges and rewards. This school year started with the nurses learning how to process required medical documents received through online registration. The task was challenging at times but so advantageous in data recording.

Our Nursing staff changed in January allowing a job share between Heidi Brumbaugh and Brittaney Cuypers at Millikin. Heidi and Brittany did a great job of working together to provide excellent care for our students, however, the job share was on a trial basis and after some discussion it was mutually decided to return to a single nurse position starting the 2020 school year. Brittany Cuypers will continue as Millikin's full time nurse. A huge thank you to Heidi for working at Millikin, and although we will not be working each day with Heidi we are fortunate to have her as one of our District nurse subs. I'd also like to thank our other substitute nurses, Cricket Elden and Diana Wallace. Our substitute nurses are invaluable.

STATE ISSUES:

Opioid Antagonist: 2019 (SB 565, Public Act 99-0480 At this time the State of Illinois does not require school districts to have on hand Opioid antagonists such as Naloxone. (Narcan). Our District liaison officer has been trained and carries with him Naloxone to be administered as needed. Geneseo CUSD currently has on hand Naloxone in all AED cabinets. We received the Naloxone free after having attended an Opioid Crisis In-service.

UPDATE May 2020: <u>Public Act 99-0480</u> has still not changed in that the State of Illinois does not mandate the schools to have Naloxone on hand. This is an optional emergency medication for school districts. Our free supply expires before the 2020 school year. We will be discussing the cost of continuing this medication, the need and the availability of the Resource officer's Naloxone supply.

Smart Seizure Act: (HB 1475, Public Act. <u>101-0050</u> As of July 2020 we are required by law to have a seizure emergency plan for any student with seizure activity. We are current with the Smart Seizure Plan requirement.

ON GOING ACTIVITY:

Computer record keeping: We continue to utilize Skyward, the school district's computer program, for data entry and record keeping. As we move forward our goal is to create a digitalized chart for each student in Skyward. We are currently able to attach med forms and physicals to information in Skyward. This will create a digital copy of the physical that students turn in to the school. In looking to the future this will provide a more efficient storing and access of school records that the state requires us to keep for 60 years.

19-20 Update: I'm excited to inform you that data entry and record keeping digitally is going extremely well. During the shelter in place I was able to archive 3 years (2013,14,15) of health records into Skyward, our server and in a cloud. The nurses scanned current records into Skyward which were then placed on our server and in the cloud also. We are moving closer to our goal of having current and archived charts digitalized for easy access and storage.

COMMUNITY CO OP: Athletic Physicals.

19-20 Update. The 2020 athletic physicals were set for May 25th but were cancelled following the COVID Pandemic restrictions. At this time the physicals have not been rescheduled for this year.

REVIEW of GOALS FOR 2019-2020 2019-2020 Goals:

The nursing team will continue to work together to provide the opportunity for all students to learn in a safe, caring and professional environment. We will remain flexible, professional, caring and compassionate nurses while providing health services to our students, staff and district families.

Update: Our district nurses demonstrate these qualities every day while interacting with students, staff and families.

Technology goal:

We will be adaptable to online registration by being flexible and open minded as how it relates to obtaining health information on our students

Update: as stated earlier the nurses have done a great job in learning new procedures in obtaining and data entry of physicals, immunizations, IHP's and medication forms. This is an ongoing learning process.

State Goals: The nursing staff will be knowledgeable and implement as needed state mandates and changes in state guidelines.

Update: This goal was met when we have our nurse's meetings and go over all the new mandates and guidelines from the State of Illinois. We update frequently on new medical guidelines, medication and procedures.

Nurses Goal:

As the providers of the district health services, the nurse's mission is to strive to provide a safe and caring environment, with high expectations for achievement, while responsibly stewarding district finances and effectively communicating.
