Superintendent Report 1/5/24

Updates from around the district and the state.

- 1. With our Christmas break being slightly later than previous years, there has not been much activity by our schools other than holiday athletic tournaments, thus a shorter than normal report for you this month.
- 2. Thursday, January 11 marks our 89th day of student attendance.
- 3. Nicole Ruthaivilavan, one of our 3rd grade teachers at Millikin, recently completed her <u>National Board Certification</u>. She should be commended for her hard work and achievement.
- 4. As requested, I have provided a breakdown of the summative evaluations for teachers for the 2022-23 school year in your folder. This is similar to the report given in December of 2022 with data for the 2021-2022 school year. Admin completed 651 required informal observations, 135 formal observations, and 77 summatives. As a reminder, all evaluators must receive two intensive initial training sessions (professional practice and student growth), pass both tests, and then must be recertified every 5 years.
- 5. Last month, we published stories on GeneseoSchools.org on the high school's Family and Consumer Science (FACS) classes, the five seniors who signed their National Letter of Intent, and a pair of upcoming events, the 2nd annual job fair and career expo at the GFAC (event overview is attached), and the FFA and Ag Alumni Trivia Night. Between our website, mobile app and social media accounts, we're doing more than ever to keep our community informed of the many great programs and people we have in the district. We always hear about unfunded mandates for school districts, but this is the first time I have seen a breakdown of the quantity and quantifiable impact on districts and local communities. 






Educational Mandates

The State Mandates Act (30 ILCS 805/3(b)) defines a mandate as any action at the state level that would cause a local education agency to *incur additional costs* in carrying out that action.

How many educational mandates are there?


Pursuant to 105 ILCS 5/2-3.104, the State Board of Education must submit to the General Assembly each year a report listing all state mandates applicable to the common schools during the school year covered by the report, excluding only those mandates that relate to school elections. Since 1982, **699 educational mandates** have been legislated. The chart above shows the trend of enacting new educational mandates is continually on the rise.

Unfunded vs. Funded Mandates

Of the 699 mandates that have been sanctioned on school districts since 1982, only 0.57% or 4 of those mandates have been funded. Almost half, or 42.49% of the mandates are unfunded. That is 297 unfunded mandates!

The remaining mandates are categorized as not posing an additional cost, yet they are expected to be carried out through existing staff and procedures. They can also create an additional cost but are expected to be covered by existing financial aid such as Evidence-Based Funding. Over 56% of all the mandates are expected to be done without additional support. That gives districts 398 additional tasks to complete! **Unfunded Mandates:** The mandate does impose an additional cost. This category will include those mandates for which there has been an appropriation. It cannot be determined, however, whether the appropriation fully covers the cost of the mandate on the Local Education Agency (LEA), nor the amount of local resources used to make up a shortfall.

Funded Mandates: Mandates that have an appropriation allocated to fully fund the initiative.

Mandates with Indirect Costs: The mandates do not impose an additional cost. This category will include those mandates that: 1.) impose additional duties of a nature that can be carried out by existing staff and procedures at no appreciable net cost increase; 2.) create additional costs but also provide offsetting savings resulting in no aggregate increase in net costs; or 3.) create an additional cost that is wholly or largely recovered from federal, state, or other external financial aid.
