

**RESOLUTION AUTHORIZING DISMISSAL  
OF FOURTH YEAR NON-TENURED TEACHER**

**WHEREAS**, the teacher hereinafter set forth is completing her fourth term of probationary teaching service during the 2009-2010 school year; and

**WHEREAS**, the Executive Board of the Rock River Cooperative Alternative School has determined that the teacher hereinafter set forth shall be dismissed at the 2009-2010 school term, pursuant to Section 5/24-11 of The School Code and has directed the Board of Education of Geneseo Community Unit School District to effectuate such action;

**NOW, THEREFORE**, Be It Resolved by the Board of Education of Geneseo Community Unit School District No. 228, Counties of Henry and Whiteside, State of Illinois, as Administrative District for the Rock River Cooperative Alternative School, as follows:

**Section 1:** Katie Brooks, a fourth year non-tenured teacher shall be dismissed at the end of the 2009-2010 school term in conformance with the Exhibit attached hereto and made a part hereof.

**Section 2:** The President and Secretary of the Board of Education are hereby authorized and directed to send the teacher a written notice of dismissal by first class mail at least forty-five (45) days before the last teacher employment day for the school term, which notice shall be substantially as set forth in the Exhibit attached hereto.

**Section 3:** The President and Secretary of the Board of Education are hereby authorized and directed to send the teacher a written notice of dismissal by certified mail, return receipt requested, at least forty-five (45) days before the last teacher

employment day for the school term, which notice shall be substantially as set forth in the Exhibit attached hereto.

**Section 4:** The Superintendent or his designee shall also personally deliver, with receipt, a copy of said notice to the teacher.

**Section 5:** This Resolution shall be in full force and effect forthwith upon its passage.
