- 5. Dr. Dean Langdon and Nesa Brauer, IASB, presented "DATA FIRST" workshop for Board of Education. (Materials provided by IASB)
- 6. The Special Meeting was suspended at 4:00 p.m. to relocate at Geneseo High School Library.
- 7. The Special Meeting was reconvened at 4:25 p.m.

- 8. Board members rotated in three groups to hear 25-minute presentations from the Elementary Schools, Middle School, and High School. Each group of Board members was able to hear all three levels during a 90-minute sequence. The buildings presented Leadership Team work, School Improvement Goals, and how they plan on monitoring initiatives.
- 9. The Special Meeting was suspended at 6:10 p.m. for a dinner break.
- 10. The Special Meeting was reconvened at 6:45 p.m.
- 11. Board Self Evaluation: (Handout: Board Retreat, June 30, 2011, Reframe, Renew, Refresh)
 - a. Mr. Kuffel shared his thoughts on "What I Need the Board to Be".
 - b. Reviewed with the Board results of the "paired conversations" that recently occurred between himself and groups of two Board Members over lunch.
 - c. Reviewed conclusions of the 1982 Citizens' Committee
 - d. Board Goal Proposals for 2011-12 and beyond:
 - Goal 1: The Board expects creation of a comprehensive and relevant **curriculum** of study for students in PreK through 12th grade, that is standards-based, articulated, and is contained within a system that contains clear timelines and expectations for monitoring, reporting of progress and systematically expects revisions where appropriate.
 - Goal 2: The Board expects creation of a comprehensive and relevant report of <u>instructional strategies</u> for teachers grades PreK through 12th grade, that is collaboratively developed between teachers and administrators, balances research-based and locally proven methods for successfully creating learning environments that maximizes high student achievement for all as evidenced on local state and national assessments.
 - Goal 3: The Board expects creation of a comprehensive and relevant learning environment in all schools and all grades that promotes appropriate use of **technology** and provides for individual engagement of all students through both personal instruction balanced with that contained within online and software-based models.
 - Goal 4: The Board expects creation of a comprehensive and relevant system that provides <u>data</u> that informs and inspires the school community through a variety of media, including print and digital means.
 - Goal 5: The Board expects creation of a comprehensive and relevant plan that demonstrates responsible **fiduciary and operational leadership**, related to the day-to-day needs of students and staff as well as the long-term sustainability of programs and physical plants of the District.

Goal 6: The Board expects creation of a comprehensive and relevant plan that builds <u>leadership</u> capacity within and across all sectors of the school district; including creating a shared vision, understanding the process of change, promoting positive and productive relationships and establishing coherence and alignment between values and actions.

- e. Plus/Delta of what was accomplished with the day and what is yet to be accomplished:
 - i. Mr. Kuffel will compile and send to Board members a "current state" report for each of the six goal areas prior to the August 11 meeting. The report will be reviewed and discussed at the August 11 meeting.
 - ii. At the August meeting, the Board will begin the process of reviewing the strategies and objectives that fit underneath those goal areas.
 - iii. At the September 8 meeting, the Board will apply the indicators of what it will be looking for that would tell Board members that progress is being made.
 - iv. Final goals will be formalized by Board action on October 13.
- f. Mrs. Mickley suggested the Board do a self-evaluation, set Superintendent goals, and measure goal progress in January or February prior to Superintendent evaluation.
