River Valley Cooperative was the lowest bidder on the diesel fuel price that is tied to the Escalation/ De-escalation clause.

ESCALATION/DE-ESCALATION CLAUSE: The bid price quoted by the Contractor will be subject to escalation or de-escalation. If at the time of delivery, there has occurred a change in the average per-gallon price of DIESEL FUEL as published in the <u>U.S. OIL WEEK'S MONITOR</u> for the Bettendorf, IA terminal from the per-gallon price published on the day of the bid opening, then the price per gallon will be adjusted from the contract price of the fuel in accordance with that change.

Gold Star FS had the lowest price for regular blend and winter blend diesel fuel for three (3), six (6), and twelve (12) month time frames. In the past month, gas prices have increased locally. Usually, prices fall in the fall and winter months. In my opinion, a six (6) month bid would be best at this time. We are currently getting diesel fuel from River Valley Cooperative for \$1.97 per gallon for regular blend and \$2.03 for winter blend.

I recommend that the Geneseo Board of Education accept the <u>fixed bid price</u> from Gold Star FS for regular blend diesel fuel (\$2.50) for a six (6) month time frame. Diesel fuel bids will be readvertised in late September, 2010, with a bid opening date of October 13, 2010.

If at the time of delivery, there has occurred a change in the average pergallon price of UNLEADED GASOLINE as published in the <u>U.S. OIL WEEK'S PRICE MONITOR</u> for the Bettendorf, IA terminal from the per-gallon price published on the day of the bid opening, then the price per gallon will be adjusted from the contract price of fuel in accordance with that change.

Gold Star FS was the lowest bidder for three (3), six (6), and twelve (12) month time frames. With the uncertainty of gas futures, the six (6) month bid from **Gold Star FS** is probably the safest. We are currently getting unleaded fuel from River Valley Cooperative for \$1.815 per gallon.

I recommend that the Geneseo Board of Education accept the <u>fixed bid price</u> for unleaded fuel for a six (6) month time frame (\$2.45) from Gold Star FS. Unleaded gasoline will be re-advertised in late September 2010, with a bid opening date of October 13, 2010.
