There are no paid time-off provisions, no insurance benefits, and no retirement benefits available to this position. Any reduction in grant funding in this contract year will alter and reduce the total hours of the District Step Grant Liaison within this agreement.

A separate timesheet shall be submitted each pay period and specifically labeled "Accompanist". Said time sheet shall be signed by Stephen LaCroix and Mr. Tom Ryerson.
